**RELEASE OF LIABILITY FOR PARTICIPANTS AGE 18 OR OVER**  
**THIS DOCUMENT AFFECTS YOUR LEGAL RIGHTS – READ IT CAREFULLY**

1. Activities. I acknowledge that I have arranged participation in weaving and fiber arts activities (the "**Activities**") through CHATTAHOOCHEE HANDWEAVERS GUILD INCORPORATED (the "**Guild**"). I represent and warrant to the Guild that I am qualified, in good health, and in proper physical condition to participate in such Activities.
2. Inherent Risks. I acknowledge that the Activities involve the risk of bodily injury and/or property damage due to the inherent risks of the Activities, which include but are not limited to: (a) possible equipment malfunction, (b) my negligence, or (c) the negligence or intentional misconduct of other persons. As the undersigned Releasor, I understand that the Guild does not require me to participate in any Activity, but I want to do so despite the possible dangers and risks and despite the terms of this Release of Liability. I HEREBY KNOWINGLY AND VOLUNTARILY ACCEPT AND ASSUME ANY AND ALL RISKS OF INJURY OR PROPERTY DAMAGE, WHETHER CAUSED IN PART BY THE NEGLIGENCE OR WRONGFUL CONDUCT OF THE GUILD, ITS EMPLOYEE, AFFILIATE, AGENT, OR ANY OTHER PERSON DURING ANY ACTIVITY.
3. Waiver; Release. I HEREBY EXPRESSLY WAIVE AND RELEASE ANY AND ALL CLAIMS, KNOWN OR UNKNOWN, AGAINST GUILD, AND HEREBY COVENANT NOT TO SUE, GUILD AND ITS OFFICERS, EMPLOYEES, AGENTS, AFFILIATES, REPRESENTATIVES, OWNERS, SUCCESSORS AND ASSIGNS (COLLECTIVELY, "**RELEASEES**"), RELATED TO INJURY OR PROPERTY DAMAGE ARISING OUT OF MY PARTICIPATION IN ANY ACTIVITY.
4. Indemnity. I hereby agree to forever defend, indemnify, and hold harmless Releasees (whether one or more) from and against any and all liability, claims, fines, settlements, damages, demands, suits or causes of action (the "**Claims**") of whatsoever nature, including but not limited to reasonable attorney's fees, arising out of the bodily injury, illness or death of any person or damage to property of any person caused in whole, or in part, by my presence in any workshop or class arranged or conducted by the Guild or participation in any Activity; provided, however, this indemnity and defense obligation shall not apply to the extent the Claims were caused by the sole negligence of the Guild.
5. Additional Terms. This Release shall be applicable for each occasion where the Guild arranges my participation in any Activity, specifically including any classes or workshops, and the terms hereof shall survive indefinitely. The unenforceability of any one term hereof shall not impact the enforceability of any other term. A signed copy hereof received or maintained electronically shall have the same legal effect as an original.

**I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED IT FREELY AND WITHOUT INDUCEMENT OR ASSURANCE OF ANY NATURE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID THE BALANCE, NOTWITHSTANDING, SHALL CONTINUE IN FULL FORCE AND EFFECT.**
